

With due respect, I, ASI Binay Subba of new Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against (i) Monoj Sarkar S/o Lt. Prantosh Sarkar of Srirampally opposite Papar Factory PS NJP Dist. Jalpaiguri and (ii) Rohit Sah S/o Nagendra Sah of Champasari near State Bank, Radhika Bhawan PS Pradhan nagar Dist. Darjeeling to the effect that on 26.06.24 myself alongwith force C/453 Uttam Dey , NVF-129 Majnu Mahammad were performing evening mobile van duty vide New Jalpaiguri PS GDE No. 1437 dt. 26.06.24. At about 18-45 hrs when we reached at Shaktigar near Gourio Math under PS NJP and found that two persons were running business Tyre garage on occupying some portion of Govt. land in front of the shop beside NH road illegally. Accordingly I inform the matter to duty officer and also O.C. PS and as per his direction myself alongwith force arrived at the spot and on seeing police party said two persons fled away leaving their shop as well as some articles which were used for encroaching the Government Land illegally. On enquiry we learnt their identity as noted above. Accordingly I removed the encroachment from the Govt. land.

I therefore, pray before you that a specific case may kindly be started against the above noted accused person namely (i) Monoj Sarkar S/o Lt. Prantosh Sarkar of Srirampally opposite Papar Factory PS NJP Dist. Jalpaiguri and (ii) Rohit Sah S/o Nagendra Sah of Champasari near State Bank, Radhika Bhawan PS Pradhan nagar Dist. Darjeeling and arrange for investigation.
