Sir,

With due respect, I, ASI Sudarshan Mandal of new Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against Pramod Majumder S/o Lt. Amrita Majumder of Fulbari Battalion More PS NJP Dist. Jalpaiguri to the effect that on 26.06.24 myself alongwith force CV-306 Biswajit Ray, CV-824 Niru Kumar yadav, CV-297 Putul Roy were performing Spl. evening mobile van duty vide New Jalpaiguri PS GDE No. 1451 dt. 26.06.24. At about 19-35 hrs when we reached at Tinbatti near Grip and found that one person was running a business Car Mechanical workshop from his shop on occupying some portion of Govt. land in front of his shop beside NH road illegally. Accordingly I inform the matter to duty officer and also O.C. PS and as per his direction myself alongwith force arrived at the spot and on seeing the police party the said person fled away leaving his shop as well as some articles which were used for encroaching the Government Land illegally. On enquiry we leant his identity as noted above. Accordingly I removed the encroachment from the Govt. land.

I therefore, pray before you that a specific case may kindly be started against the above noted accused person namely Pramod Majumder S/o Lt. Amrita Majumder of Fulbari Battalion More PS NJP Dist. Jalpaiguri and arrange for investigation.
