Sir,

In producing herewith one seized vehicle blue coloured TATA Intra bearing Reg No- WB 71 C 0132, Engine No- 1.5CR09KWXSE3372 and Chasis No- MAT 535324PYK50733 along with two cow, I, PSI Avijit Banik of Matigara Police Station, Siliguri Police Commissionerate beg to report that today i.e. on 26.06.2024 at night I along with force was performing Special night mobile van duty under Matigara PS vide Matigara PS GDE No- 1328 dt-26.06.2024.

During patrolling van duty at about 01:25 hours we found one blue coloured Tata Intra having regd. WB 71 C 0132, going towards Khaprail More, we signalled the driver of said vehicle to stop. The driver of the vehicle rushed from there without giving any importance to our signal towards Shivmandir. Then we chased the vehicle to intercept it. At around 01:45 hrs the vehicle was stacked at the Railway level crossing near Shivmandir Medical More which was closed for passing the train and broke the barrier of the level crossing gate. Four persons including the driver who were in the vehicle were able to escape from the spot leave the vehicle by taking the advantage of the rain and darkness. After searching the vehicle we found that two cows are fastened tightly in the goods compartment of the vehicle. We searched for the accused persons at the nearby places but we could not find any one. Accordingly I seized the vehicle bearing no- WB 71 C 0132 along with two cows [(i) One is white coloured having two small horn and (ii) Other one is white coloured and light red colour at head having two small horn in which one is in broken condition] in presence of the independent witnesses. The seizure was made in between 02:05 hours and 02:20 hours. Both the cows were given as Zimma to one namely Lal Babu Ray, S/O- Ram Asrey Ray of Sishudangi, PO+PS- Matigara, Dist- Darjeeling for taking care.

Under the above circumstances, I pray that a specific case under proper section of law may kindly be started against the driver/owner of vehicle blue coloured TATA Intra bearing Regn No- WB 71 C 0132, Engine No- 1.5CR09KWXSE3372 and Chasis No- MAT 535324PYK50733 and other associates.
