Sir,

Today on 26/06/2024 I ASI Basudeb Banarjee along with force, all of Matigara P.S. were engaged in performing Mobile patrol duty from 14:00 hrs to 22:00 hrs. At about 15:15 hrs I was directed by the on duty officer ASI Mangal Kilku to assist the officials of B.D.O. Office Matigara for joint visit at City Centre under Matigara P.S. Accordingly a joint visit was conducted by the authority of B.D.O. office Matigara and myself on behalf Matigara P.S. regarding encroachment of Govt. Land by the hawkers. During Joint visit in between 15:25 hrs to 15:45 hrs on 26/06/24 it could be detected that one Binod Gupta (27) S/O Mohan Shaw of Shib Nagar, P.S. Matigara is selling Green Coconut, encroaching Govt. Land, beside National Highway 31, near City Centre, P.S.- Matigara, Dist.- Darjeeling.

This is to be noted here that he was reportedly cautioned verbally by the authority of B.D.O. office Matigara previously not to encroach Govt. land for his personal gain. It seems that he is not willing to leave said encroached Govt. Land.

Under the above circumstances I pray before your kind honour that a specific case may kindly initiated against Binod Gupta (27) S/O Mohan Shaw of Shib Nagar, P.S. Matigara, Dist.- Darjeeling under proper section of law and arrange for it's investigation.
