At about 15:15 hrs I was directed by the on duty officer ASI Amal Roy to visit the land encroached inside the campus of North Bengal Medical College and Hospita under Matigara P.S. Accordingly myself alongwith force I went to N.B.M.C. & Hospital campus to visit the encroachment of Govt. Land by the hawkers.
