Sir,

Today on 26/06/2024 I ASI Bijay Khaskel along with force, all of N.B.M.C OP under Matigara P.S. were engaged in performing Mobile patrol duty from 14:00 hrs to 22:00 hrs. At about 15:15 hrs I was directed by the on duty officer ASI Amal Roy to visit the land encroached inside the campus of North Bengal Medical College and Hospital under Matigara P.S. Accordingly myself alongwith force I went to N.B.M.C. & Hospital campus to visit the encroachment of Govt. Land by the hawkers. During visit in between 21:10 hrs to 21:30 hrs on 26/06/24 it could be detected that one Pankaj Sarkar S/O Lt. Ramesh Sarkar of Kawakhali, P.S. Matigara, Dist.- Darjeeling is selling Tea, Launch, clothing etc, preparing temporary shed, encroaching Govt. Land, North Bengal Medical College & Hospital campus, Sushrutnagar, P.S - Matigara, Dist.- Darjeeling.

This is to be noted here that he was cautioned verbally previously, not to encroach Govt. land for his personal gain. It seems that he is not willing to leave said encroached Govt. Land.

Under the above circumstances I pray before your kind honour that a specific case may kindly initiated against Pankaj Sarkar S/O Lt. Ramesh Sarkar of Kawakhali, P.S. Matigara, Dist.- Darjeeling under proper section of law and arrange for it's investigation.
