With due respect I, Sri Partho Pratim Dey, Son of Sri Dilip Kumar Dey, resident of Hakimpara, P.O. & P.S. Siliguri, Dist.- Darjeeling, the constituted attorney of Reba Dey who is my mother, would like to inform you the following facts:-

- 1. That my mother is the absolute owner in possession of the land measuring 35 kathas recorded in khatian no. 36/2 (old) and 162/1 (new), Plot no. 125 (old) and new plot no. 211, Mouza- Khawakhali, P.S. Matigara. Sub- Division Siliguri, sub- registry office- siliguri (now Bagdogra), District: Darjeeling (W.B.) by virtue of two separate deeds of sale being no. 1802 for the year 1991 purchased from one sri Birendra Kumar Saha, Son of Late Bankim Chandra Saha, land measuring 20 katha or .33 acre and deed of sale being no. 1803 for the year 1991 from one sri Atul Chandra Saha, Son of Late Nani Gopal Saha, land measuring 15 Kathas or .25 acre and in these way my mother purchased 35 kathas or .58 acre.
- 2. That my mother filed a suit bearing no. T.S. no. 43/2004 before the Ld. Civil Judge Senior Division at Siliguri against Anil Kumar Roy, Nitish Roy, Nimai Roy, Biswajit Roy all are sons of Late Amulya Roy, Ganesh Sarkar, Son of Late Bancharan Sarkar, Amal Roy, Son of Anil Kumar Roy and Swapan Roy, Son of Anil Kumar Roy as they were trying to encroach upon the land of my mother. Kumar Roy has been dismissed. The judgment and decree has been passed after full fledged trial.

- 4. That in spite of passing the judgment and decree against them they are again trying to fence the land of my mother by bamboo posts. Now Anil Kumar Roy and others are trying to occupy the land of my mother forcefully when they found that the judgment and decree favouring my mother had already been passed.
- 5. That on 26.06.2024 I went to the land and found that Anil Kumar Roy along with Amal Roy, Son of Anil Kumar Roy, Swapan Roy Son of Anil Kumar Roy Nitish Roy, Nimai Roy, Biswajit Roy all are sons of Late Amulya Roy, Ganesh Sarkar, Son of Late Bancharan Sarkar, the aforesaid s persons were digging up soil to fix bamboo posts in order to surround the land illegally, when I raised objection against their illegal deeds. All of them armed with lathi, sword, hasua, hammer and chased me and intimidated me to cause of my murder and also threatened me that they all are associated and established leaders of political party their political party has influenced them to take forcible possession of the land by disposing me as they do not fear any law and order neither police administration or any court orders. I was frightened and somehow saved my life. They threatened me with dire consequences not to appear there further.
- That they are very much adamant to occupy the land of my mother forcefully and they have no regards to the law.

Therefore I request you to investigate into the matter and to take legal action against them and thereby I shall be obliged to you.
