Sir,

In producing herewith three (03) accused persons namely [1] Sanjit Mandal (22), S/O- Anath Mandal, [2] Ananda Biswas (58), S/O- Lt. Madhu Biswas and [3] Fani Mandal (45), S/O- Lt. Naresh Mandal all are of 18 No Milanpally, PS- Bhorer Alo, Dist- Jalpaiguri under arrest along with (i) one plastic chair under proper seizure, I beg to report you that today on 26.06.2024 around 18.45 hrs in course of Mobile Van duty vide MCC No. 955/2024 Dt. 26.06.2024, I along with my accompanied force had been to Bhorer Alo Tourism Property area under PS- Bhorer Alo and found above noted persons were engaged in hawking at the back side of "Hawa Mahal" at Gajoldoba under PS- Bhorer Alo, Dist- Jalpaiguri obstructing the public way. Accordingly, I seized the plastic chair with which they had obstructed the public way and further arrested them observing all formalities.
