Sir,

I, ASI Lakshan Kr. Singha of Panitanki TOP under Siliguri PS Siliguri Police Commissionerate, do hereby lodge a written complaint against (i) Debasish Roy (34 Yrs) S/O Sudhir Roy of Krantir hat near Kranti Bazar, PS-Malbazar, Dist -Jalpaiguri and (ii) Sandip Saha (37 Yrs) S/O Lt Rabindra Nath Saha of Sukantanagar, W/No 38 PS-Bhaktinagar, Dist -Jalpaiguri to the effect that today i.e on 26.06.24 at about 16.05 hrs receive information from duty officer that a chaos is being going on beside Bidhan Road near Bidhan market in between few pedestrian and two road-side shop keepers over the issue of illegal encroachment of foot-path. Accordingly as per instruction of O/C, TOP myself along with C/1036 Gopal Srivastav and C/114 Naresh Hansda left for Bidhan Road Near Bidhan Market to work out the information. During enquiry it could be learnt that a chaos was took place beside Bidhan Road near Bidhan market in between few pedestrian and a road-side shop keeper over the issue of illegal encroachment of foot-path. During further enquiry it could be learnt that both the shopkeepers fled away from their shops. During enquiry it also could be learnt from pedestrian that said shopkeeper illegally occupy the road-side foot-path beside Bidhan Road and encroaching the same by illegal means which causes great inconvenience among the pedestrians and due to which several road accidents were also occurred in earlier occasion. In course of further enquiry it could be learnt from other shop owners of Bidhan Market that the above noted shop keepers running their shops by illegally occupied the foot path and they have no legal documents or Title in r/o their shop. During enquiry it revealed that name & address of the said shop keepers are (i) Debasish Roy (34 Yrs) S/O Sudhir Roy of Krantir hat near Kranti Bazar, PS-Malbazar, Dist -Jalpaiguri and (ii) Sandip Saha (37 Yrs) S/O Lt Rabindra Nath Saha of Sukantanagar, W/No 38, PS-Bhaktinagar, Dist.-Jalpaiguri.

Hence, I pray that a specific case may kindly be initiated against the above noted accused persons named (i) Debasish Roy (34 Yrs) S/O Sudhir Roy of Krantir hat near Kranti Bazar, PS-Malbazar, Dist -Jalpaiguri and (ii) Sandip Saha (37 Yrs) S/O Lt. Rabindra Nath Saha of Sukantanagar, W/No 38, PS-Bhaktinagar, Dist.-Jalpaiguri for illegal encroachment of the public foot-path and causing endanger the life of public in general and arrange for its investigation.
