Rakhal Nafladi of Chayanpara, W/No. 37, PS-Bhaktinagar, Dist -Jalpaiguri to the effect that today i e on 26.06.24 at about 16.15 hrs as per instruction of O/C, TOP myself along with C/984 Subhasish Das and C/233 Nagen Ch. Barman left for Bidhan Road Near Bidhan Market to work out an information. During enquiry it could be learnt that a chaos was took place beside Bidhan Road near Bidhan market in between few pedestrian and a road-side shop keeper over the issue of illegal encroachment of foot-path. During further enquiry it could be learnt that both the shopkeepers & his employee fled away from their shop. During enquiry it could also be learnt from the pedestrians that said shopkeeper illegally occupy the road-side foot-path beside Bidhan Road and encroaching the same by illegal means which causes great inconvenience among the pedestrians and due to which several road accidents were also occurred in earlier occasion. Hence, I pray that a specific case may kindly be initiated against the above noted accused persons named ((i) Nakul Roy (65 Yrs) S/O Lt. Kuti Ram Roy of Hakimpara, W/No. 16, PS-Siliguri, Dist -Darjeeling and (ii) Ratan Nandi (45 Yrs) S/O Lt. Rakhal Nanadi of Chayanpara, W/No. 37, PS-Bhaktinagar, Dist -Jalpaiguri for illegal encroachment of the public foot-path and causing endanger the life of public in general and arrange for its investigation.
