Respected Sir/Madam;

I Smt. Jayanti Rakshit (Mandal), wife of Sri Koushik Rakshit, resident of Guru Saday Dutta Road, Rabindra Sarani, Bharat Nagar, Ward no. XXIV, Post Office- Rabindra Sarani, Police Station- Siliguri, Dist-Darjeeling, PIN-734006 would like to bring to your notice that:-

- 1. I am married to Sri Sri Koushik Rakshit, from the last 12 years. Our marriage was solemnized on 29/11/2012 according to Hindu rities and customs.
- 2. After our marriage, my mother-in-law namely Smt Bharati Rakshit and father-in-lawSri Mukul Rakshit both residents of Guru Saday Dutta Road, Rabindra Sarani, Bharat Nagar, Ward no. XXIV, Post Office- Rabindra Sarani, Police Station- Siliguri, Dist- Darjeeling, PIN-734006began to torture me, clearly displeased with my husband's choice to marry me. Shortly after moving into our matrimonial home, I began to notice unsettling behavior from my mother-in-law, who was involved in an extramarital affair with a person named Shyam Sundar Kedia, son of unknown, resident of Bowbazar, Shanti Nagar, Police Station-Siliguri, Dist- Darjeeling When I confronted my husband about this, he sadly confirmed it. Despite our earnest request to her to cease such activities within our home, my mother-in-law remained unbothered and continued to subject both my husband and me to torture.

Also it is pertinent to mention here that my mother-in-law and my father in law have taken 2 Lakh Rupess in cash, gold jewellaries and furniture as dowry.

- 3. My mother-in-law has been engaged in such activities for the past 25 years. After my marriage, I confronted her about stopping these actions within our household, explaining the negative impact they have on society. In response, she firmly stated that she has no obligation to interfere in anyone's personal life and proceeded to verbally abuse me in a condescending manner. Despite repeated requests from both me and my husband, she continued these activities, causing significant distress within our marriage and home.
- 4. In 2019, my daughter was born, and now she is 5 years old. As she grows older, she has started asking me about a person who comes into our house and inquiring about his identity. I find myself at a loss for words because she is still very young, but she can sense and understand the situation that exists in our home.
- 5. Witnessing these activities and considering my daughter's future, as she could develop negative perceptions from such behaviors within our home, I once again confronted my mother-in-law and father-in-law. I requested them to cease these actions within our household. My mother-in-law slapped me harshly, and my father-in-law grabbed me by my

hair, asserting that I should not meddle in their personal affairs. He emphasized that this person (referring to Shyam Sunda rKedia) bears all the household expenses and belittled my husband, stating that he is incapable of managing the household.

6. It is pertinent to mention that I also have a **sister-in-law named Mousumi Rakshit** also of Guru Saday Dutta Road, Rabindra Sarani, Bharat Nagar, Ward no. XXIV, Post Office-Rabindra Sarani, Police Station- Siliguri, Dist- Darjeeling, PIN-734006, who is partially handicapped and unable to speak. She is also involved in these activities with her parents. Whenever my mother-in-law and father-in-law verbally and physically abuse me, using abusive language and hitting me, my sister-in-law Mousumi Rakshit also participates. She throws objects at me in attempts to cause physical harm and worsen the situation.

It is pertinent to mention here that the sisters of my mother-in-law are also involved in supporting her in all her activities.

- 7. Many times, my husband has pleaded with them to stop creating such a hostile atmosphere in our home. He has emphasized that their behavior is not only disturbing our marital life but also affecting the future of our young child, who is only 5 years old. Despite his earnest requests, they refuse to listen and remain adamant about continuing their harmful behavior.
- 8. That feeling helpless and seeing no other option, about a week ago, I tracked down the house of Shyam Sundar Kedia and went there to inform his family about his extramarital affair with my mother-in-law. During this conversation, I learned that Shyam Sundar Kedia also engages in abusive behavior towards his wife, who has little control over her own life and decisions.
- 9. However, since that day, Sri Shyam Sundar Kedia has not visited our house, which has greatly angered my mother-in-law and father-in-law. On23/06/2024, my mother-in-law came into my bedroom while I was sleeping, grabbed me by my hair, slapped me, and kicked me. My father-in-law also joined in, verbally abusing me, accusing me of interfering in their lives, and emphasizing Shyam Sundar's importance in their family as he financially supports them. They also insulted me and my family with derogatory language.

It is pertinent to mention here that Sri Shyam Sundar Kedia too threatened me with dire consequences, in retaliation for informing his family about his extramarital affair with my mother-in-law. He has even threaten to end the lives of me and my husband

- 10. Soon, my husband arrived home and found me in this distressing situation. He attempted to intervene and stop my father-in-law and mother-in-law, but they turned their abuse towards him as well. They retrieved a knife from the kitchen and threatened to harm both me and my husband if we continued to interfere in their lives. They also warned that if Shyam Sundar did not return to their house within 2 days, they would kill both of us.
- 11. Since my marriage, I have been living in extreme anxiety and depression due to the toxic behavior within our household. This environment has caused significant mental distress for both me and my husband, and it is affecting our marriage. Unfortunately, due to my

husband's limited financial strength, we are unable to move to a separate residence with our young daughter. I am constantly living in fear and under threat due to the abusive behavior of my mother-in-law and father-in-law.

I am a victim of prolonged domestic violence. My sincere request is for you to kindly investigate this matter thoroughly and take appropriate legal actions against, mother-inlaw namely Smt Bharati Rakshit and father-in-law Sri Mukul Rakshit and sister-inlaw named Mousumi Rakshit Your intervention is crucial to ensuring our safety and wellbeing. As I have been subjected to prolonged domestic violence. Please take the necessary steps to address this situation promptly.
