Sir,

With due respect and in producing herewith 02 persons namely (i) Biswajit Sahani (22 yrs) S/O Raju Sahani of Jyotirmay Colony, PS- Matigara, Dist. Darjeeling and (ii) Rutpal Barman (27 yrs) S/O Narendra Barman of Jyotirmoy Colony, PS- Matigara, Dist.- Darjeeling under arrest and one truck having registration number WB/73/D/4804 Laded with illegal River bed materials under proper seizure list. I, ASI Manoj Kr Roy of Pradhan Nagar P.S, SPC do hereby lodge this Complaint against the the above noted two accused persons namely (i) Biswajit Sahani (22 yrs) S/O Raju Sahani of Jyotirmay Colony, PS- Matigara, Dist. Darjeeling and (ii) Rutpal Barman (27 yrs) S/O Narendra Barman of Jyotirmoy Colony, PS- Matigara, Dist.- Darjeeling to the effect that on 28.06.24 at 00.05 hrs I received a specific source information that one truck bearing Reg. No. WB/73/D/4804 loaded with illegal River bed materials is coming from Debidanga Mahananda river Bed, under PS- Pradhan Nagar, Dist.- Darjeeling and proceeding towards Champasari More without any valid documents. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1465 dated 28.06.24 and informed the fact to the you and as per his kind order and direction myself along with force had been to Masjid More near Circuit House under PS- Pradhan Nagar, Dist.- Darjeeling. At around 00.45 hrs the source informed me that the said vehicle crossed Champasari more and proceeding towards Circuit house side. At around 00.55 hrs we detained the said truck displaying number plate WB/73/D/4804 loaded with illegal River bed materials at Masjid More near Circuit House under PS- Pradhan nagar, Dist.- Darjeeling and also found that two persons were inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above and Biswajit Sahani was driving the vehicle. On demand he failed to produce any documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation they disclosed that they mines such river bed materials from Mahanda river near Milan More by illegal means with a view to sell the same for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/73/D/4804 leaded with illegally mining river bed materials under proper seizure list and subsequently arrested them after maintaining all formalities of arrest and brought to Pradhan Nagar PS. The search and seizure was made on 28.06.24 in between 01.30 to 02.20 hrs.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Biswajit Sahani (22 yrs) S/O Raju Sahani of Jyotirmay Colony, PS- Matigara, Dist. Darjeeling and (ii) Rutpal Barman (27 yrs) S/O Narendra Barman of Jyotirmoy Colony, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
