I am the ill fated father of my son namely Aasish Sharma
aged about 25 years, met with a fatal accident, today
on 27-06-24 at approx 11:00 AM. at JSNM Mandir Road
near Kali Mandir Anchal Nore. I have learnt about the
incident from my relatives stationed in Siliguri and
local media that one vehicle to which license being
Reg No - WB/79B/3227 whose registered owner is not
known to me. But as per information the accident
occurred due to rash and negligent driving of the
driver (name not known) of the above noted offending
vehicle and the driver managed to escape from the
place of occurrence.

My son Aasish Sharma was riding on a Scooty whose
registered number is WB/74AR/8874 who was also
the registered owner and had a valid driving license
bearing no WB 73 2022 0017813 valid up to 7/08/28

Accordingly, I pray to you to investigate the instant
case and book the offending driver and owner
of the vehicle with appropriate provision of law,
so that such evildoer and negligent drivers are
punished for their unaccounted negligent act.
Local people admitted my son at Ananda Lok Nursing
Home and the attending Dr. elected him as
