(Subj:- Attempt of murder, theft & violence against my person)

Sir,

With due respect and humble submission I Javed Miyaabada s/o
Md. Imtiaz resident of Manipur Yojna, P.O - Kanpur, District :- Kanpur
Nagar, Uttar Pradesh- 208002 went to Hotel Central Park along
with my friend namely Prem Saha while coming out from Hotel
Central Park at about 4 am on 23/06/2024 with my friend, suddenly
Sudev Rudra s/o Sudhir Rudra resident of Haldenpara along with his
3 friends men harassed me and snatched my 2 gold rings approx
price is Rs 50,000/- and Sudev Rudra hit me with bamboo stick
on my head. I suffered deep cuts & bleeding was uncontrollable.
Then my friend took me to nearby Anandolor Hospital where
attending doctor treated me and 18 stitches were done on my head.
Prem Saha who was with me also suffered neck injury by
a knife stab by one of the friends of Sudev Rudra. There
intention was to murder or kill me. I was fatally unconscious
when I was brought to Hospital from the Hotel Premises.

Requesting you to take strict & proper actions against the
accused & find the others related to crime scene.
