Sir,

With due respect, I ASI Everentius Dempta of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the following persons namely i) Joshna Biswas, W/o-Rabi Biswas, ii) Kapila Trikhatri, W/O-Mrinal Trikhatri iii) Namita Bala, W/O-Late Balaram Bala (iv) Bhuwan Khati, S/O-Santosh Khati all are of Bhujipani under PS-Bagdogra, Dist-Darjeeling for trying to encroached the govt. land.


Today on 26/06/2024 while I along with force namely C/778-Kamal Lama, CV/390-Sampad Singha were performing evening van duty vide Bagdogra PS GDE No-1336 dated-26/06/24 at about 18.15 hrs found that the above noted accused persons encroached the service road of Bagdogra Airport and started running temporary shop over it, thus creating obstruction of free flow of traffic as well as pedestrian. When we tried to apprehend them the accused persons ran away from the spot along with their belongings. There after I caused an enquiry to nearby people who disclosed the accused persons name and identity as mentioned above. During enquiry I also came to know that the accused persons were running their said temporary shop from last couple of days and local people many time asked them not to use the service road for their temporary benefits as it is purely an encroachment on Govt. land and also creating obstruction of free flow of traffic.

Under the above facts and circumstances, I request you that a specific case against the aforesaid persons may kindly started with suitable sections of law.
