Sir, I Taziya Khatun, the above noted complainant beg to inform you that, on dt. 28.06.2024 at about 02:30 pm, when my husband was at coal Depo on the road, at that time (1) Md. Nurul (2) Md. Nazrul @ Pappu S/o Md. Nurul & (3) Md. Sahil S/o Md. Nazrul all one of Coal Depo, Ward No. 7 P.S-Siliguri, were in intoxicated condition and were brutally attacked by my husband namely, Akbar Ali S/o Md. Tazul Ali, of coal Depo, with, iron knuckle punch, leather Belts & knives, therefore I called my family members and relatives namely, (1) Md. Samim (34) S/o Md. Abdul Samad (2) Md. Wasim Barik (26) S/o Abul Samad (3) Md. Samir @ Sahil S/o Md. Purvez, all one of coal Depo, Ward No. 7, P.S-Siliguri, & along with them tried to save my said husband namely, Akbar Ali (16) S/o Tazul Khan, of coal Depo, Ward No. 7, P.S-Siliguri, but the above noted alleged persons suddenly attacked on us with iron knuckle punch, leather Belts and knives and injured my family members & relatives namely, (1) Akbar Ali (16) S/o Md. Ekbal Khan (2) Sahil (20) S/o Md. Purvez (3) Wasim Barik (26) S/o Abul Samad and me, and the above noted alleged persons torn off my clothes and disrobed me, and stolen away Rs. 25000. (Keeps Twenty five thousands) only and a Gold chain from my brother namely, Md. Samim (34) S/o Abul Samad of coal Depo, Ward No. 7, P.S-Siliguri, and left the place.

Sir, the all injured persons were immediately shifted to Siliguri Distt. Hospital and treated themselves there. So, please take necessary action against above noted alleged persons.
