Sir,

I Sri Rabi Shankar Singh S/o Sri Baijanath Singh, resident of Gandhinagar, near the House of Ex-Councillor Sri Dilip Singh, P.O. - Sevoke Road, P.S. - Bhaktinagar, District Jalpaiguri, would like to inform you that I am constituted attorney of my grandson Sri Guddu Singh S/o Mahatom Singh resident of Tumbajote, P.S - Matigara, District - Darjeeling. My principal alongwith one Rajesh Singh have jointly purchased the land measuring about 2 Kathas recorded in R.S Khatian No- 789 corresponding to LR Khatian No - 1556, Plot N 1372 under Mouza - Toomba, Paragana - Patharghata, P.S - Matigara, District - Darjeeling by virtue of registered deed of sale dated 13 - 6 - 2005 duly registered in the office of ADSR, Siliguri II at Bagdogra, in Book No - 1, Being No - 3720 for the year 2006 and subsequently the said Rajesh Singh has sold his share in the land i.e. 1 Katha land to some body else and my principal has started possessing and enjoying his 1 Kathas land freely and openly and the said land also recorded in the name of my principal. In the year 2018 one Junglee Bin S/o Biswanath Bin, Anil Mala S/o Late Rampat Mala both are of Shishudangi, Matigara and Kishore Das @ Mukhia S/o Late Basudeb Das of Beldangi, Matigara, Darjeeling, Sri Suman Kalyan Pradhan S/o Padam Prasad Pradhan and Smt. Geeta Baraily Pradhan W/o Suman Klayan Pradhan resident of Agomoni Abasan, Block E - 2, Dangipara, Siliguri District Darjeeling have procured some fabricated document in respect of the aforesaid landed property and they alongwith one Ajay Mahato have sold the said land of my principal to One Madhu Sen S/o Jogesh Sen of Ashrampara, Siliguri vide deed No - 3721 for the year 2018 registered before the ADSR, Bagdogra and subsequently the above named land mafiyas have declared the land as vest and have again sold to Radha Yadav S/o Not Known Durga Yadav S/o Not Known, Smt Sapana Yadav W/o Radha Yadav, Sri Mohan Yadav and Sri Krishna Yadav S/o Sri Radha Yadav without my knowledge and consent. Yesterday i.e. 29 - 6 - 2024 I had been to the aforesaid landed property and find that the above named land mafiyas have sold and transferred the land to the above named persons against huge consideration price and the said Radha Yadav and others are by constructing one katcha structure are residing and when I have raised my objection, they became furious and have about to assault me with threatening that if had have been seen the locality, they will kill me. Soon after fleeing from there, I had been to Junglee Bin, Anil Bin Kishore Bin, Suman Kalyan Pradhan but they instead of making any attempt to resolve the dispute, have threatened me not to disturb them as well as the said Radha Yadav in any manner. The above named persons have illegally disposed my principal and forcefully occupied the land for their illegal gain and wrongful loss to my principal. I further came to know that the above named persons have criminal record and several cases are pending against them and they have no regard in law and order. So requesting you to investigate the matter and take necessary legal actions against the above named persons for the interest of justice.
