Today on dated 30.06.24 at about 1700 hrs an incoming BD National passport no. A11850188 DOI-21/08/23, Valid up to 20/08/2033, Visa No. VL – 8350935, D.O I – 14.04.2024 and valid up to 09.10.2024 namely- Md Manik Islam S/O Md Abu Sayed, R/O - Vill Bongaon, P/O Rongaon, Distt -Dinajpur, P/S - Bochaganj, Pin -5216 came from BD side. On search by Pers of 151 Bn BSF at passenger checking point, he seemed to be a little nervous. Upon further checking following Indian documents were recovered from his possession

Upon further questioning the said BD national gave contradictory statements and cooked up a different story. The individual did not reveal the exact purpose of his visit but told that he was going to meet one person named robiul islam( Mob no. 8653703775) at Raiganj, WB to further move to New Delhi for work. His activities and conduct seems to be suspicious as he has illegally crossed border on earlier occasions. Therefore, it is requested to lodge an FIR to further investigate under which circumstances and motive he was trying to come to India carrying Indian documents.
