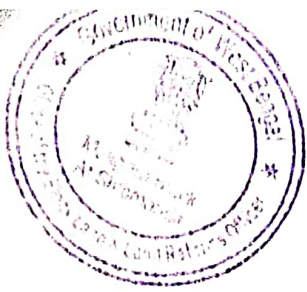

Sir,

This is to bring to your notice regarding illegal occupation of
Government Land (Vest Land) under Mouza - Karaibari, S.L 39, by
one Dhurba Subba, address - unknown, and other unknown persons.

It is stated that - as per verbal instruction from ADM & DERO, Darj
on 29/06/2021 regarding illegal encroachment of Govt. (Vest) Land at
Mouza - Karaibari, a team consisting of officials from the office of the
undersigned and from B.D.O. Office Maligara along with police
team from Pradhan Nagar P.S. visited the concerned area on
30/06/2021 at around 10 a.m. As per field investigation done by
Office Amin and Revenue Inspector, it transpires that the following
C.I.R plots no. of Mouza - Karaibari i.e. plot no: 1058, 1061, 1062, 934, 1039,

1040, 1067, 1068, 1029, 946, 932, 933, 931
908, 907, 1042, 1041, 1044 1516/18 plots
recorded in favour of the Govt. of West Bengal have been illegally
occupied by constructing brick wall, iron pillar and four nos. of
Kutchra tin shed. After being confirmed of the same, these illegal structures
have been dismantled/demolished with the help of JCB in presence of
myself and B.D.O. Maligara.

Now at this juncture, I request you to take immediate action against
these illegal occupants to prevent further unauthorized use of
government land.
