I, Mr. Samir Sarkar, S/o. Mano Sarkar, Supervisor of P.S. ENTERPRISE, residence at Champasari Ganesh Ghosh Colony, Ward No. 46 of SMC, Siliguri -734003, Dist : Darjeeling, would like to draw your kind attention that one Amulya Ghising (Lama), son of late Dhan Bahadur (Lama) resident of Pathaghata Road, Salbari, Siliguri 734002, District-Darjeeling, with whom I have entered in to a tenancy agreement to run my Hoarding advertising business at the premises of Amulya Ghising. That I have been regularly paying rent to Amulya Ghising to carry on my business however in spite of complying with all the terms and condition of the said tenancy agreement the said Amulya Ghising always tried to resisted my employees to work. That due to such disturbances I was compelled to file a civil suit in the Siliguri sub division Court at Civil Judge Junior division vide T.S Case no: 243/2023 where the Id Court was pleased to pass an ad interim injunction in favour of me. That in spite of that the said Amulya Ghising did not stop his mischief activities. That on 13.01.2024 & 04.04.2024 Amulya Ghising and his associates stole iron rods and tube lights amounting of Rs 1,20,000/- . That again on 24.06.2024 the said Amulya Ghising along with his associates stole Flex, tube lights to a tune of 60 pieces, 4 iron rods from my hoarding which is situated at Church More Sevok Road Siliguri. That due to which I have suffered a loss of Rs. 1,40,000/- . That on 24.06.2024 I called in his phone no 9851159005 and he admitted that he has stolen my above mentioned properties and threatened me that he will continue to steal if I do not vacate his premises.

Therefore I humbly request you to kindly recover the stolen properties and book the offender.
