I, Ranjit Mahato, Son of Dasrath Mahato, resident of Durga Nagar, Rishi Arvinda Raod, Ward No. 40 of S.M.C., P.O Sevoke Road, P.S. Bhakti Nagar, Dist. Jalpaiguri, would like to inform you the following facts:-

- 1. That Raju Mahato, aged about 16 years, is my son he is the student of Class X of Nirman Bidya Jyoti School, lower Bhanu Nagar, Siliguri.
- 2. That on 28.6.2024 at about 9:30 p.m. when my son Raju Mahato was coming back from his coaching at that time (i) Ankit, Son of not known, (ii) Babu Roy, son Jayanto Roy, (iii) Binoy, Son of Mithilesh, (iv) Prince, Son of not known, all are resident of Durga Nagar, P.O Sevoke Road, P.S. Bhakti Nagar, Dist. Jalpaiguri, along with other 3 / 4 person whose face my son could not saw due to darkness, stopped my son at a dark lonely place near Durga Nagar Sporting Club and started demanding money from him, on the protest of my son they caught hold my son and started searching the pocket of my son but they could not found any cash amount at that time out of anger they started assaulting my son without any reason for almost 15 to 20 minutes and in such assault they broke my son nose as a result blood was oozing out from his nose. Then they above named culprits started strangulating my son's neck with intention to kill him. Seeing their intention to kill my son started raising hue and cry and para people gathered on the spot and save him, but before that one of the culprits snatched gold neck chain from my son's neck and fled away from there.

Sir, without any reason the above named culprits tried to kill my son and looted him. Sir, if the para people had not come at the spot and rescued him at that moment then those culprits would have killed my son.

- 3. That thereafter, we came to know about the incident then we rushed to the spot. And my son was given first aid but one the next day his condition became bad and seeing is bad health condition we were compelled to admit him in a Maya Sannayal Nursing Home, Siliguri on 29.6.2024 where lots of test, MRI, X-ray and his nose operation was done, and on 01.7.2024 the doctors discharged him.
- 4. That due to the grievous injury of my son, we all were busy in his treatment as such I did not lodge FIR in due time which may be condoned.

I, therefore, request you to kindly take necessary legal action against the aforesaid persons in the aforesaid matter.
