Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with SI Basudeb Guah, SI Youel Lepcha, ASI Chandra Prakash Adhikary, LC /1248 Puja Tamang left PS to Bethgara, Salugara under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.174, dated-04.07.2024. On reaching there and as identified by the source it found that one lady namely Teluni Adhikary (F/40yrs) of the said shop was selling liquor. Subsequently, I along with officer and force cordoned the shop and was able to detain the above noted lady with the help of LC/ 1248 Puja Tamang Subsequently on being asked the apprehended lady disclosed her name and identity as noted above. Further being searched the above noted bottles of liquor were found from the said shop. On demand she failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 16.45hrs hrs to 17.15 hrs at the spot. The whole process of seizure was videographed by mobile phone. As she has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended lady accused person namely Teluni Adhikary (F/40yrs) W/O- Bablu Adhikary of Bethgara, Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri after keeping her decency and after observing all sorts of formalities u/s 35 BNSS appraising her the ground of arrest.
