Sir,

In producing herewith one arrested lady accused person namely Teluni Adhikary (F/40yrs) W/O- Bablu Adhikary of Bethgara, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

1. 19 (Nineteen) Bottles of Kingfisher Strong Beer (each bottle containing 650ml) [Total 650 ml X19 = 12 ltr 350 ml]
2. 02 (two) Bottles of Tuborg Premium Strong Beer (each bottle containing 650ml) [Total 650 ml X2 = 1 ltr 300 ml]
3. 05 (five) Bottles of Mc Dowell's No-1 Luxury Premium Whisky (each bottle containing 1800ml) [Total 180 ml X5 = 900 ml]
4. 01 (One) Bottles of Mc Dowell's No-1 Luxury Premium Whisky (each bottle containing 750ml)

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one lady namely Teluni Adhikary (F/40yrs) W/O- Bablu Adhikary to the effect that today on 04.07.2024, at about 15.40 hrs received a source information that liquor selling is going on one grocery shop by a lady situated at Bethgara, Salugara under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with SI Basudeb Guah, SI Youel Lepcha, ASI Chandra Prakash Adhikary, LC /1248 Puja Tamang left PS to Bethgara, Salugara under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.174, dated-04.07.2024. On reaching there and as identified by the source it found that one lady namely Teluni Adhikary (F/40yrs) of the said shop was selling liquor. Subsequently, I along with officer and force cordoned the shop and was able to detain the above noted lady with the help of LC/ 1248 Puja Tamang. Subsequently on being asked the apprehended lady disclosed her name and identity as noted above. Further being searched the above noted bottles of liquor were found from the said shop. On demand she failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 16.45hrs hrs to 17.15 hrs at the spot. The whole process of seizure was videographed by mobile phone. As she has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended lady accused person namely Teluni Adhikary (F/40yrs) W/O- Bablu Adhikary of Bethgara, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri after keeping her decency and after observing all sorts of formalities u/s 35 BNSS appraising her the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against lady accused person namely Teluni Adhikary (F/40yrs) W/O- Bablu Adhikary of Bethgara, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
