Sir,  
I Smt. Anuradha Pradhan Das, w/o. Sri Dipanjan Das, D/o. Indra K. Shrestha and Chm Chm Pradhan, currently residing at Salbari, Siliguri Pol PS Pradhan Nagar, would like to state that I had made a written complaint dated 15/05/2024 before the Inspector-in-Charge, Siliguri women PS and specific case being initiated in Siliguri women PS case no. 49/2024 dated 16/05/2024 U/S 498A/406/313/506/376.

Since the date of making the said complaint, I have been receiving threats from my in-laws and more specifically by my husband. I have also made a subsequent complaint regarding threats on 12/06/2024 at women PS. on the same day my husband and in-laws come to my parents home at Salbari and forcefully took away all my (hold) jewellery, Important documents, cloths and other necessary things because of that I do not have cloths to wear and go to work and they reside at Thapa mansion, Flat-3 Dushbandhupara, Siliguri. My father-in-law & mother-in-law have been enlarged on bail by jurisdiction court, however my husband is still roaming freely and escaping police arrest.

It is pertinent to mention that on 27/06/2024 while I was going to work near Salbari two men and agents sent by my husband threatened to kill me if I do not withdraw the complaint I made before police. Again on 29/06/2024 at around 5:30 near Darjeeling more, my husband with one more man stopped me and physically abused me and said he will kill me nobody can do any harm of him because he has powerful connection that is why he is escaping arrest and said send me arrest warrant. Again on 01/07/2024 around 6:00 pm between City center to Darjeeling more my husband stopped my scooter on the way and pushed me and I fell down and he kissed me and said "kuch din ka mahman hai Dharti main".

Under this circumstance, I am in a constant state of fear and threats of my life and finding no other alternative I wish to inform and seeking help from you this physical, mental harassment by husband and request your intervention and necessary action against my Husband and in-laws.
