I Puja Chakraborty w/o Arka brata Chakraborty Presently residing at Champasari, Dhaknikata, Murgji Khela math and permanently residing at Ashoke Nagar, Shak Higash near Tapan Store, Siliguri, hereby report that I was severely physically Assaulted by my brother in-law M.R. Sujit Barman on 01/07/2024 at his own Permanent residence at champasari, Dhaknikata, murgji khela math. This is the second time that I was Physically Assaulted by him. Last time the same incident occured about a month ago, but I forgave him for the sake of my elder sister. But this time he tortured me along with my elder sister severely, I got a severe cut on my right arm. I visited Govt. Hospital for Primary treatment and got six stitches on my wound. After Assaulting us he also gave us life threat that I we complain to Police about the matter then he will see us afterwards. He drinks alcohol in a regular basis.

So Sir, I hereby request you to take legal actions against M.R. Sujit Barman as early as possible and provide us Protection. we are spending our time in a insecure way.
