By virtue of a registered Deed of General Power of Attorney registered in the office of the Additional District Sub Registrar of Siliguri II at Bagdogra, District Darjeeling being Document No 040308946 for the year 2023, Registered in Book – I, Volume No 0403-2023, pages from 180055 to 180066 and the said General power of Attorney has been executed by the owner Smt Sita Rai, Wife of Dawa Lama, Indian by

nationality, Hindu by religion, Service by occupation, resident of Upper Sichey (B), P.O & P.S - Gangtok, Dist East Sikkim, Pin- 737102, Sikkim.

It is pertinent to mention here that all the owners above named had purchased the aforesaid lands from one Kiran Gurung, S/o Late Nar Bahadur Gurung, Hindu by religion, Indian by nationality, Service by Occupation, resident of Development area, P.O & P.S Gangtok, Pin 737101, Dist East Sikkim, Sikkim in the year 2013 by virtue of separate Deed of Conveyance being deed no 04197/2013, 01235/2013 and 04199/2013 respectively.

- 2) That sir as all the above-named principals (i.e., owners) reside in the state of Sikkim and due to their un-ability, all of them have appointed me as a care taker for their land above mentioned.
- 3) That sir few months back I came to know that some un-authorized person have started to construct a boundary within the aforesaid land of the principals as such I, rushed to the site where I, discovered that those persons were employed by one land mafia namely Laxman Sharma, S/o Not Known operating its business in the name and style of Saraswati Acres Pvt Ltd having its office at Matigara Quantum Building 4th floor P.S Matigara, knowing this I collected his phone no and contacted him, thereafter the said Laxman Sharma asked me to visit him in his office situated at Matigara Quantum Building 4th floor P.S Matigara following which I went to his office where he pressurized me to sell the aforesaid land of the principals as they have appointed me their lawful attorney and had also offered me an amount of Rs. 1,00,000/- (Rupees One Lakhs) only per katha for executing such document.
- 4) That sir he has also stated that even if I don't execute such document he would capture and grab the land belonging to the principals by any means by hook or by crook as he has got sufficient means to do so and he is a big land mafia operating in the area.
- 5) That sir I have also learned that the previous vendor Shri Kiran Gurung, S/o Late Nar Bahadur Gurung was working in partnership with the said land mafia Laxman Sharma, at the time of the plotting of the entire land and the said Laxman Sharma, S/o unknown was very well aware of the fact that the principals namely (i) Shri Sisir Basnett, (ii) Smt Indra Kumari Chettri and (iii) Smt Sita Rai are permanent

resident of Sikkim and would not be able to look after their land, therefore taking advantage of their vulnerability the said Land Mafia Laxman Sharma, S/o unknown has managed to manufacture forged and fabricated document in the name of his brother-in-law namely Kumar Chettri @ Kaila and his wife.

6) That Sir, for few months I, was out of station due to my election duty posting, however yesterday dated 01/07/2024 I, visited the land of the principal again and I was astonished to see that the said Laxman Sharma has constructed another boundary within the lands of the principal and some antisocial employed by the said Laxman Sharma has threatened me of Life if I, dare to visit the land and the said antisocial have forcefully dragged me out of the property.

That sir in the light of the afore stated facts and circumstance it is crystal clear that previous vendor namely Kiran Gurung, S/o Late Nar Bahadur Gurung his accomplices Laxman Sharma, S/o (name unknown) and brother-in-law of Laxman Sharma namely Kumar Chettri @ Kaila and Kumar Chettri's wife (name unknown) has been involved in cheating the principals abovenamed, manufacturing forged and fabricated documents pertaining to the land above mentioned only to blackmail the principals for grabbing their land and only to cause them financial loss for their unlawful gains.

Therefore, I do hereby request you to kindly register my complaint and kindly take appropriate action as per law.
