Sir,

In producing hare with one accused person namely Akash Das (31 yrs) S/O Late Laxmi Das of Road No -08, Pati Colony, PS- Matigara, Dist.- Darjeeling under arrest along with the following articles under seizure viz :- (i) one paper made cartoon containing 12 (twelve) bottles of TUBRG Premium Beer each bottle containing 650 ml i,e, total (650 x 12) = 7.8 ltrs, marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1". (ii) one paper made cartoon containing 12 (twelve) bottles of KINGFISHER STRONG Beer each bottle containing 650 ml i,e, total (650 x 12) = 7.8 ltrs, marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B-1", (iii) One nylon bag containing 07 (seven) bottles of Md Dowell's Whisky, each bottle containing 180 ml i,e, total (180 x 07) = 1.260 and 06 (six) bottles of India made liquor styled as PRAKASH60, each bottle containing 600 ml I,e total (06 x 600) = 3.6 lts marked as "Exhibit C" out of which one bottle of the same from each quantity taken as sample for examination and marked as "Exhibit C1 & "Exhibit C2" and (iv) One white colour Jupitar Classic Motor Cycle (Scooty) having Registration number WB/74/AT/7978, marked as "Exhibit D". I, SI Goutam Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against accused person namely Akash Das (31 yrs) S/O Late Laxmi Das of Road No -08, Pati Colony, PS- Matigara, Dist.- Darjeeling to the effect that on 04.07.24 at 17.15 hrs I received a specific source information that one person named Akash Das carrying huge quantity of illegal liquor by his motor cycle having registration number WB/74/AT/7978 and will come at Gate Bazar side. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No 203 dated 04.07.24 and informed the fact to you. Subsequently, being directed by you myself along with SI Bandhan Roy, ASI Biplab Kr Das, C/1413 Sujit Sarkar, C/1419 Ashis Roy all of Pradhan Nagar PS, SPC left for Gate Bazar under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information. After arrival at Gate Bazar and contacted with my source while he informed me that the said person will come at Gate Bazar side with huge quantity illegal liquor. Accordingly, we waiting for the said motor cycle. After a few time we managed to detain the said motor cycle (scooty) having registration WB/74/AT/7978 at Gate Bazar loaded with two paper made cartoons and one nylon bag. Thereafter, we disclosed our identities as Police personnel (as we all were in civil dress for our convenience) and informed him regarding the information in hand and stated to him that he would be searched in person for the said purpose. On interrogation he disclosed his identity as noted above. On being search the above noted seized articles were recovered from his possession. On demand he failed to produce any valid license/papers for selling and storing of such illicit liquor. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his wrongful gain. Then, I seized and labelled the above mentioned illicit distilled liquor under proper seizure list from the possession of accused Akash Das (31 yrs) S/O Late Laxmi Das of Road No -08, Pati Colony, PS- Matigara, Dist.- Darjeeling and subsequently, arrested the above mentioned detained person namely Akash Das (31 yrs) S/O Late Laxmi Das of Road No -08, Pati Colony, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities on the spot for violating the norms of the Bengal Excise Act. The whole process of search and seizure was made in between 19.05 hrs to 20.01 at the spot under the coverage of video graph.

Therefore, I pray before your good self that a specific case may kindly be initiated against accused Akash Das (31 yrs) S/O Late Laxmi Das of Road No -08, Pati Colony, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
