8. Reasons for delay in reporting by the Complainant / Information

- (i) 01 automatic small fire arm (Pistol) measuring 19 cm (approx) in length with trigger, trigger guard, striking hammer, striking pin in working condition loaded with 02 (two) round live ammunition recovered and seized from the possession of accused Francis Kispotta and marked as "Exhibit-A" & "Exhibit-B" (ii) one iron made sharp cutting weapon locally called as Khukri measuring approx 14 inches in length including its wooden butt recovered and seized from the possession of accused Abhishek Oraon (iii) one iron made sharp cutting weapon locally called as Khukuri measuring approx 13 inches in length including its wooden butt and iron made rod locally called as Khukuri approx 10 inches in length recovered and seized from the possession of accused Gautam Mahato (iv) one iron made sharp cutting weapon locally called as "Dagger" measuring 15 inches in length including its wooden butt and one iron made instruments called as "Plus" recovered and seized from the possession of accused Amit Singh and (v) one iron made sharp cutting weapon locally called as "Khukri" measuring 10 inches in length including its wooden butt and its cover and one Scruve driver measuring 11 inches in length recovered and seized from the possession of accused Sudesh Khali.

Sir,

In producing herewith five (05) accused persons namely (i) Francis Kispotta (33 yrs) S/O Late Alexix Kispotta of Basa Line, Gayerkata T.E. PS- Banarhat, Dist.- Japlaiguri (ii) Abhishek Oraon (19 yrs) S/O Kison Oraon of Kawatuli, Jugijhora, PS- Birpara, Dist.- Alipurduar, (iii) Goutam Mahato (30 yrs) S/O Late Sonaram Mahato of Factory Line, Damanpur T/E, PS+Dist. Alipurduar, (iv) Amit Singh (19 yrs) S/O Late Saltu Singh of Gurung Busty, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Sudesh Khati (27 yrs) S/O Late Bimal Khati of Gidde Pahar, PS- Kurseong, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) 01 automatic small fire arm (Pistol) measuring 19 cm (approx) in length with trigger, trigger guard, striking hammer, striking pin in working condition loaded with 02 (two) round live ammunition recovered and seized from the possession of accused Francis Kispotta and marked as "Exhibit-A" & "Exhibit-B" (ii) one iron made sharp cutting weapon locally called as Khukri measuring approx 14 inches in length including its wooden butt recovered and seized from the possession of accused Abhishek Oraon (iii) one iron made sharp cutting weapon locally called as Khukuri measuring approx 13 inches in length including its wooden butt and iron made rod locally called as Sarasi measuring approx 10 inches in length recovered and seized from the possession of accused Goutam Mahato (iv) one iron made sharp cutting weapon locally called as "Dagger" measuring 15 inches in length including its wooden butt and one iron made instruments called as "Plus" recovered and seized from the possession of accused Amit Singh and (v) one iron made sharp cutting weapon locally called as "Khukri" measuring 10 inches in length including its wooden butt and its cover and one Scruce driver measuring 11 inches in length recoverd and seized from the possession of accused Sudesh Khati. I, SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted five (05) arrested accused persons and their 03/04 unknown associates who involve in this crime to the effect that on 04.07.24 at 23.30 hrs received a specific source information that about 08/09 persons assembled in a abandon room situated at Dagapur near Savin Kingdam under PS- Pradhan Nagar, Dist.- Darjeeling equipped with fire arms and deadly weapons and were taking preparation for committing dacoity at Dagapur and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 224 dated 04.07.2024. As per your kind order and direction, at about 23.40 hrs. I accompany with ASI Manoj Kr. Roy, ASI Biplab Kr Das, C/1169 Prasenjit Barman, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Dagapur near Savin Kingdam under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 225 dated 04.07.2024. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come to Dagapur near Savin Kingdam with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer ASI Sanjay Roy of Pradhan Nagar PS and directed him to come at Dagapur near Savin Kingdam. At around 00.05 hrs the above noted vedigrapher arrived at Dagapur near Saving Kingdam. I briefed him properly. Then, I requested two available independent witness namely (i) Manoj Kr Das (34 yrs) S/O Late Sahadeb Das of Kawakhali, PO- Sushruta Nagar, PS- Matigara, Dist.- Darjeeling and (ii) Subhajit Dey (36 yrs) S/O Ratan Dey of Kawakhali, Medical More, PO- Sushruta Nagar, PS- Matigara, Dist.- Darjeeling (Both the security guard of Savin Kingdam) and informed them about the information and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, I contacted with my source and as pointed by the source we noticed that 08/09 persons assembled in a abandon room near Savin Kingdam, Dagapur and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel, they tried to flee away from the spot but on hot chase we managed to apprehended above noted five (05) accused persons with fire arms and deadly weapons in their possessions while 03/04 others managed to flee away from the spot through back side open window and taking the opportunity of darkness and back side jungle. Thereafter, we disclosed our identities as Police personnel (as we all were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with fire arm and ammunition and deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Dagapur and its surrounding areas.


Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.05 hrs to 02.00 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling. I, accordingly brought all the five (05) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Dagapur and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Dagapur and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Francis Kispotta (33 yrs) S/O Late Alexix Kispotta of Basa Line, Gayerkata T.E. PS- Banarhat, Dist.- Japlaiguri (ii) Abhishek Oraon (19 yrs) S/O Kison Oraon of Kawatuli, Jugijhora, PS- Birpara, Dist.- Alipurduar, (iii) Goutam Mahato (30 yrs) S/O Late Sonaram Mahato of Factory Line, Damanpur T/E, PS+Dist. Alipurduar, (iv) Amit Singh (19 yrs) S/O Late Saltu Singh of Gurung Busty, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Sudesh Khati (27 yrs) S/O Late Bimal Khati of Gidde Pahar, PS- Kurseong, Dist.- Darjeeling and others 03/04 unknown miscreants and arrange for its investigation.
