Coochbehar, would like to inform you that I purchased a piece of land measuring 2 Katha 2 Chattak within specific boundary from one Sri Chitra Singha, S/o Biman Singha, resident of Kawakhari, Medical Collage More, P.O. Sushruta nagar, Police station - Matigara, Dist- Darjeeling by virtue of Registered deed of Sale which was executed by said Chitra Singha on 7<sup>th</sup> day of December 2005 and the same is recorded in Book No I, Vol No. 168, Page No 381 to 388 Being document No. 6808 for the year 2006 which is fully described in the scheduled below and since then I have been enjoying possession of the said land having absolute right, title and interest therein free from all encumbrances and charges whatsoever.

That the persons named above are not only illegally encroach my land but they also started illegal construction over my below schedule land, when I protest their illegal activities they threatened me in filthy languages with dire consequences.

That they are men of desperate in nature and have a very notorious reputation and I feel fear of my lives and property from them and I feel that they can go to any extent to fulfill their illegal and notorious intension.

Therefore, I would like to humbly request you to look into the matter immediately and stop their illegal construction over my land also kindly help me to retain my lawful property and do the needful, your prompt and proper action in this regard is highly solicited.
