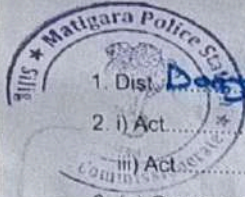

Respected Sir,

I, Smt. Kanchan Singha wife of Sanjay Singha, resident of Tulakata Jote, Post- Kadamtala, PS- Matigara, Dist- Darjeeling, 734011. Beg to state as follow:-

1. That Jyotirmoy Singha is my son, who preparing for WBCS examination and used to stay at Kolkata for coaching and also giving competitive exam and till now he is unemployed.
2. That my son's life is in critical situation due to conspiracy made by Rina Singha, her father Bisadu Singha and her brother Bikash Singha resident of Salkavita, Post- NBU, PS-Matigara, Dist- Darjeeling, 734013.
3. That the real fact is that Rina Singha is a desperate and oftenly used to stay outside home and stay to her different friend's houses. On 24/05/2024 to 25/05/2024 Rina Singha stayed two nights with her friend's house Himani Bala at Indirapally, Post- Kadamtala, PS- Matigara, Dist- Darjeeling, 734011.
4. That on 26/04/2024 at morning 9:30 am she went to her home, her father Bisadu Singha scolded and beaten her. As she often used to stay in nights outside of her home.
5. That on the same day 26/04/2024 Rina Singha call my son at NBU gate no- 2 and she stated the above matter and intent to committed suicide. As she is very depressed from her parents behavior. My son did not understand and bring her to my residence. I given food and told her not to commit suicide as she requested me that she want to stay at night in my house and she slept with my daughter. Next morning she went to her office 'Lifestyle' at city center and return back to my house again, then after a few minutes her father and brother reached my house and told her daughter that they will not allow to her at home. So I give strong objection to her parents and I told Rina Singha to leave my home. She

- started to assault me with filthy languages and even assault me physically. Rina Singha forced me to give marry with my son.
6. That Bisadu Singha, Bikash Singha and Rina Singha forcefully taken my son to their house and kept under their custody and organized marriage forcefully at Kalibari Halermatha with my son on 4<sup>th</sup> May 2024 without our presence. And Bisadu Singha had taken a room for rent in Diya house at Satyenbose Road.
  7. That after forcefully having marriage, my son came to know that Rina Singha has so many boyfriends and having sexual relationship. She is also habituated of smoking and drinking alcohol and other bad habits.
  8. That there is a full conspiracy of Bisadu Singha, Bikash Singha and Rina Singha to demand money from us.
  9. That they all started to harass physically and mentally. They started to threaten my son and demanding money from my son and force him to take money from us. Rina Singha also conspired along with her boyfriends to beat my son if my son not obey and fulfill their demand. They also threaten my son by saying that if he not obey their words then Rina Singha will lodge a complaint against my son and having no choice.
  10. That Bisadu Singha did not pay the room rent Rina Singha went to parents house and they filed a complaint against my son on 21/06/2024 at Matigara Police Station (Case No.-382/2024) as my son did not fulfilled their demands.
  11. That my son's life is in critical position and may cause any incident at any time or ant any place.
  12. That any incident or accident occurred or may cause harm during this period, then Rina Singha, Bisadu Singha and Bikash Singha will be responsible.

So, I do hope that you should be kind enough to investigate the matter and take proper step in favour of me and save my son's life.
