I, Shree Prosenjit Bala, son of Prabash Bala and resident of Dayaram Jote, P.S + P.O -Naxalbari, Dist - Darjeeling, WB - 734429, am writing to report a tragic incident involving my elder brother, Pramath Bala, aged approximately 28 years.

On 01-07-2024 at around 1:00 PM (noon), my brother was traveling on his bike, a Royal Enfield Classic Chrome 350 with registration number WB74BD5185 (Chassis No ME3U3S5F2LL979376, Engine No. U3S5F1LL612622), heading towards Bagdogra from Ghoshukur on NH-27. Unfortunately, near Bhujiya Pani, he collided with a white INOVA car bearing registration number WB73E1999.

The collision resulted in critical injuries to my brother, and despite our immediate efforts to rush him to North Bengal Medical College, the doctors there pronounced him dead upon arrival.
