Sir,

With due respect, I am producing herewith one accused person namely Sunu Majhi (45) w/o Lt. Chhotu Majhi of Bhujipani, PS Bagdigra, Dist. Darjeeling brought under arrest and the following articles under seizure. The ground of arrest duly been communicated with her.

1. Two Drums each contains 05 (Five) Ltr filled with Id liquor "Cholai" measuring Total-10 Ltrs.
2. Total 120 Ltrs Kachamal (Raw materials) Farmented wash for making Id. Liquor (Chullu) in six drums, each drum contains 20 ltr (Seized and destroyed).
3. Approx ½ kg of white colour tablets/medicine (Bakor) for making Id liquor "Chullu"

I, ASI Amit Lama presently attached with BDR PS under your kind control beg to state that today i.e. on 04.07.2024 at 11.50 hrs I received a secret source information that one person namely Sunu Majhi (45) w/o Lt. Chhotu Majhi of Bhujipani, PS Bagdigra, Dist. Darjeeling is selling ID liquor illegally at her house. Accordingly, I diarized the fact in the General diary vide Bagdogra PS GDE No. 150 dated 04.07.2024 and informed the fact to you. As per your kind direction and instruction myself along with ASI Munna Ahamed and force all of BDR PS, SPC left for Bhujipani under PS-BDR, Dist.- Darjeeling to work out the information in hand. At about 12.30 hrs we arrived Bhujipani, PS- BDR, Dist.- Darjeeling and being identified by the source I found the said accused person selling Illegal Distilled liquor to regular customers at her house and hold raid at her house and managed to apprehended her. During interrogation she disclosed her identity as noted above and also disclosed that she is selling ID liquor at her house since long for her illegal gain. On search the above noted I/D liquor recovered from his shop. On demand she failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from house. Accordingly, I seized the above noted I/D liquor from her possession under proper seizure list and arrested her under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure and arrest was made in between **14.23 hrs to 14.40 hrs**

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused namely Sunu Majhi (45) w/o Lt. Chhotu Majhi of Bhujipani, PS Bagdigra, Dist. Darjeeling and arrange for its investigation.
