- 1. Eight (08) Nos sealed Bottles of Himalayan FATAFATI country spirit, each bottle 300 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
- 2. Eight (08) Nos of sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that on 04.07.24 at 19-15 hrs received source information that one person was selling Liquor illegally from infront of his shop at NJP station near NJP Truck Stand under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself along with ASI Nilam Swarnakar, C/1462 Sajan Tamang CV/824 Niru Yadav CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Station near Truck stand to verify the veracity of information vide NJP PS GDE No. 233 Dated- 04.07.24.
