Sir,

In producing herewith two (02) arrested accused persons namely (i) Narayan Mandal (32) S/o Lt. Lakhon Mandal of Kamrangaguri PS. NJP, Dist. Jalpaiguri and (ii) Sanat Barman (18) S/o Lt. Parmesh Barman of Paschim Dhantala PS NJP Dist. Jalpaiguri with the following articles under proper seizure as per seizure list;

I) One improvised Pistol, having Butt, Body, barrel, Trigger, Firing pin & a Magazine Catch measuring about 8(Eight) inches in length, approx 4 inches butt.

II) Two (2) Nos of 7.65 mm live cartridges.

iii) One Scooty having No. WB-74-BR-7883, Model TVS NTORQ, 125 CC, Blue Color.

I, SI Ganesh Roy of New Jalapiguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely (i) Narayan Mandal (32) S/o Lt. Lakhon Mandal of Kamrangaguri PS. NJP, Dist. Jalpaiguri and (ii) Sanat Barman (18) S/o Lt. Pranesh Barman of Paschim Dhantala PS NJP Dist. Jalpaiguri to the effect that on 04.07.24 at about 22-45 hrs, I received a specific source input that two persons with one Scooty having No. WB-74-BR-7883 are possessing improvised fire arms are waiting at Kashmir Colony Ground to sell the same to his designed local customer clandestinely. The matter was diarised vide New Jalpaiguri PS GDE No. 250/24 Dt. 04.07.24. Subsequently, I informed the matter to you and with your prior permission and being directed, myself along with SI Tanmay Kundu, C/152 Abdul Kayum Miah, VP-13 Jamirul Islam. CV-297 Putul Roy CV/824 Niru Yadav CV/306 Biswajit Roy with investigation kit left for Kashmir Colony ground under New Jalapiguri PS by Govt. vehicle to verify the veracity of the information vide NJP PS GDE No. 251 dt. 04.07.24.

After reaching at Kashmir colony Ground at around 23-10 hrs, After about fifteen minutes waiting thereafter being pointed by my source I found that two persons were sitting in a Scooty at Kashmir Colony Ground and on seeing police party, they tried to flee. On hot chase, we intercepted Scooty having No. WB-74-BR-7883 and apprehended 02 (One) persons. On being asked he disclosed his identity as noted above. We disclosed our identity and on searching of the apprehended persons and Scooty above, found one of them he was possessing exclusively two live ammunition on his tight pocket of wearing pant of Narayan Mandal and on searching of the Scooty one pistol, having butt, Body and Barrel and Magazine catch kept in the dikky of the said Scooty. On asking they could not produce any valid license/document in respect of possession of the carrying arms (pistol) and two (2) rounds of live ammunition. On being interrogated they disclosed that the owner of Scooty is mother of Sanat Barman and they were carrying the improvised illegal arms and ammunition to sell the same to one of their designated customers clandestinely of Kashmir Colony for illegal gain which was purchased cheaply from Bihar side. He could not disclose the name of his designated customers.

Thereafter, I seized the recovered improvised Pistol, having butt Body, barrel, Trigger, Firing pin & a Magain Catch measuring about 8(Eight) inches in length, 4 inches butt along with Two (2) pieces of 7.65 mm live cartridges in presence of witnesses namely (1) Niramay Basak (27) S/o Nitish Basak of Kashmir Colony PS New Jalpaiguri Dist. Jalpaiguri (2) CV/824 Niru Yadav of NJP PS, SPC after observing all the formalities obtaining their signature in seizure list being acknowledged by the both

accused persons and witnesses. Subsequently, I labelled and sealed the seized articles i.e. Arms and ammunition. The whole process of seizure was made in between 23-25 hrs to 23-45 hrs.


Then, I arrested the above noted accused persons namely (i) Narayan Mandal (32) S/o Lt. Lakhan Mandal of Kamrangaguri PS. NJP, Dist. Jalpaiguri and (ii) Sanat Barman (18) S/o Lt. Parmesh Barman of Paschim Dhantala PS NJP Dist. Jalpaiguri u/s 35(1) BNSS after observing all formalities and informing the ground of arrest at 23-45 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the above noted two accused persons namely (i) Narayan Mandal (32) S/o Lt. Lakhan Mandal of Kamrangaguri PS. NJP, Dist. Jalpaiguri and (ii) Sanat Barman (18) S/o Lt. Parmesh Barman of Paschim Dhantala PS NJP Dist. Jalpaiguri and arrange for its investigation.
