I am Pradip Karmakar, S/o Prafulla Karmakar and I own a shop namely; Bidhan Jewellery located in NeelKamal Plaza, Hill Cart Road, Siliguri

I wish to report to you the following incidence:

I park my car in the basement parking in Neelkamal Plaza and a few days ago found that another car bearing registration number WB74BK2017 was parked in such a way that it was blocking my car. On query it was found that the car belonged to one Mr. Ramesh Agarwal who does not own any space in Neelkamal Plaza nor is he renting any space there. It was later brought to my notice that he has an office in the nearby PNB Building. After frantic search of more than one hour the driver, Prasenjit Roy of said car belonging to Mr. Ramesh Agarwal could be located and he was asked to remove the car from the premises. He was also instructed that this was a private parking and only the owners or their authorized people were allowed to park their cars and that too in a way not to cause any blockage or harm to any one or any other vehicle.

Again on 31-05-2024, just after 7.30pm, it was found that the same vehicle was again parked in Neelkamal Plaza parking. On inquiry it was found that, inspite of being informed that he should not be parking in the premises, Mr. Ramesh Agarwal had not stopped parking his car there. Since this was going on repeatedly, it seems that this was being done intentionally by Mr. Ramesh Agarwal. After locating the driver, Prasenjit Roy, I once again raised my objection to his car being parked there. The driver then summoned his owner, Mr Ramesh Agarwal. I too informed other shop/office owners of Neelkamal Plaza and some of whom also arrived promptly at the site. On being called by his driver, Mr. Ramesh Agarwal arrived at the site alongwith his son, Abhishek Agarwal and his staff Madan Dutta. His driver

was already at the site. I once again raised my objection to his parking the car in the building since it was a private parking and not any public parking. At this Mr. Ramesh Agarwal and his son became very furious and started shouting and threatening that they were lawyers and who-so-ever prevented them from parking their car there would face dire consequences. They also said that such a

person could also be put behind bars by implicating them in a false case or any other means. They also threatened me of bodily harm if I once again raised any objection to their parking their car. This was done in presence of other shop/office owners of Neelkamal Plaza.

I am since very afraid that he might try to implicate a false case or cause me bodily harm either by self or through his goons. It may kindly be noted that Mr. Ramesh Agarwal is also a land mafia and is trespassing and trying to encroach our parking space through dubious means as he is neither a owner/tenant of any portion of the building.

Following this incidene, I along with other shop/office owners brought this incidence to the notice of Hill Cart Road Byabasayee Samiti and we held a meeting with the President. They too were of the opinion that outsiders should not be allowed to park their vehicles in the building since this could not only cause inconvenience but this could pose a serious security threat.

Sir, I hope that you will look into this matter and arrange to prevent Mr. Ramesh Agarwal from parking his car in our private parking space of Neelkamal Plaza.

This is for your kind information and necessary legal action.
