With due respect and humble submission, I ASI Debasish Das, S/O- Shri Haripada Das of Siliguri PS under Siliguri Police Commissionerate do hereby lodge this written complain after producing herewith the above-noted seized articles to the effect that on 04.07.24 at 13.15 hrs while performing PS mobile van duty received source information that one person namely Dulal Sutradhar was selling liquor in his house situated at South Bharat Nagar, under Siliguri PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Siliguri PS GDE No- 195 dated 04.07.24 As per your kind instruction myself along with PSI Koushik Raha, ASI Subir Sen, and force proceeded to the PO to work out the ihformation. At about 13.45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid at the house of the above-noted accused person and able to detain one person, who disclosed his identity as noted above. On being searched the above-noted bottles of liquor recovered from his house. Further, being asked he confessed that he is doing the business of selling and storing liquor in his house since long for his wrongful gain without any valid documents/license. Then, in the presence of available witnesses, I seized the above-noted articles from the PO after prepared proper seizure list. (The seizure was made in between 14.05 hrs to 14.45 hrs). As he has violated the rules and norms of Bengal Excise Act, I arrested the apprehended accused person namely Dulal Sutradhar (M/52 years) S/o- Lt. Ratan Sutradhar of South Bharat Nagar, ward no-24, P.S-Siliguri, Dist-Darjeeling after observing all sorts of formalities u/s 35 (1) of BNSS appraising him the ground of arrest.
