In producing herewith the accused person namely Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Loose one (01) bottle of Mc. Dowell's No.1 Reserve Whisky contains 750 ml @ Rs. 400/- (for sale in Sikkim only).
 2. Loose half (½) bottle of Royal Stag Deluxe Whisky contains approx 375 ml (half of 750 ml) @ Rs. 307/- (for Defense Service only).
 3. Loose three (03) bottles of Mc. Dowell's No.1 Superior Whisky, each contains 375 ml @ Rs. 330/-.
 4. Loose one (01) bottle of Mc. Dowell's No.1 XXX RUM contains approx 600 ml.
 5. One sealed bottle of Himalayan Gold 60° UP India Made Liquor contains 300 ml @ Rs. 100/-.

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling to the effect that on 05.07.2024 at 17:25 hrs I received reliable source information that a huge quantity of liquor is stored at the hotel of one Pradip Jaiswal situated at Panighata Road under PS- Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with other officer & force VP/01 Ansalam Kujur, VP/02 Prodip Roy & CV/386 Kishor Howladar left for Pradip hotel at Panighata Road to work out the secret source information. This refers to Bagdogra PS GDE No. 216 dated 05.07.2024. At around 17:45 hrs we reached at Panighata Road and had been waiting for the source indication. After a while, the source indicated the hotel and we planned for holding raid. We saw one customer inside the hotel. Then we proceeded to hold raid at the hotel of suspect Pradip Jaiswal and managed to apprehend one person there and interrogated him. On interrogation, he revealed his identity as Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling and introduced himself as the owner of said hotel. We disclosed our identity and the input we had to him. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely John Roy (25 years), s/o- Late Sombaru Roy, resident of Khalpara, PO- Naxalbari Bazar, PS- Naxalbari, Dist- Darjeeling and Pawan Mahato (40 years), s/o- Sri Mukhlal Mahato, resident of Panighata Road, near Hanuman Mandir, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling agreed to be present as witness. Then, we conducted search at the said hotel in presence of independent witnesses. On search, the above noted liquor was recovered from the said hotel. On demand, he failed to produce any valid document/license for stocking and selling that liquor. He further confessed that he has been stocking and selling liquor illegally from his hotel for a long time for his wrongful gain. Accordingly, I seized that liquor under proper seizure list and at last, arrested the accused Pradip Jaiswal (as noted above) after observing all legal formalities and telling him the ground of arrest and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 18:27 hrs and 18:42 hrs on 05.07.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and after recording, the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
