complaint against the arrested accused person namely Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling to the effect that on 05.07.2024 at 17:25 hrs I received reliable source information that a huge quantity of liquor No 218 Dt is stored at the hotel of one Pradip Jaiswal situated at Panighata Road under PS-Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with other officer & force VP/01 Ansalam Kujur, VP/02 BDR Prodip Roy & CV/386 Kishor Howladar left for Pradip hotel at Panighata Road to work out the secret source information. This refers to Bagdogra PS GDE No. 216 dated 05.07.2024. At around 17:45 hrs we reached at Panighata Road and had been waiting for the source indication. After a while, the source indicated the hotel and we planned for holding raid. We saw one customer inside the hotel. Then we proceeded to hold raid at the hotel of suspect Pradip Jaiswal and managed to apprehend one person there and interrogated him. On interrogation, he revealed his identity as Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS-Bagdogra, Dist- Darjeeling and introduced himself as the owner of said hotel. The process of search, seizure & arrest was made in between 18:27 hrs and 18:42 hrs on 05.07.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and after recording, the same audio-video record is converted to a pen drive using computer system.

> Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Pradip Jaiswal (56 yrs), s/o- Late Viku Jaiswal, resident of Panighata Road, Upper Bagdogra, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
