Our crescent court building is guarded by a security guards one of them is MD. Kalam who is incidentally a handicapped night guard of our building and vulnerable to physical threat. I have CCTV footage which shows Mr. Santanu Guha on 24/06/2024 around 9.40 pm came on a scooter, alighted from his scooter and started assaulting our security guard violently without any reason. He first stopped the security guard, held him firmly and pulled him to the ground. Mr. Santanu Guha then pulled him up, manhandled him and threw few blows at him. The security guard seemed visibly shaken by this and walked out the confrontation. The behavior of Mr. Santanu Guha was dangerous and clearly assaults could have been fatal.

Then the night guard due to fear ran up to the first floor and entered into my clinic. In mean time, Mr. Santanu Guha called his wife and son and started bad mouthing towards me and let out loud explicit words trying to malign me and my reputation. They tried to gather people, intervene and they threatened violent gestures towards me.

At this point I was scared about the safety and security. On this situation I called up police station for seeking help, accordingly police personal from your police station came in our building and provided me with necessary shelter, and reach me to my home. I am truly grateful to your police station for the gesture.

Under the above circumstances. I pray before you kindly enquiry the matter and take necessary action as per law.
