Respected Sir/Madam.

With due respect, I Santanu Guha, son of Sir Prodyut Kr. Guha, of Mahananda Para Chanda Park, P.O. Siliguri bazar, P.S. Siliguri, Dist. Darjeeling, would like to draw your kind attention in the matter that on 24.06.2024 at around 9:30 pm. I was returning from work through Jhankar More, while passing that area it came to my notice that one person was pelting stones and a big chunk of broken concrete on a pregnant bitch mercilessly, due to such assault it got injured on her leg and back, being, an animal lover I advanced to the spot which was in front of the Kishan Code building, reaching there I could see that the watchman of that building was assaulting the dog. Who was pregnant and was restraining in that premises.

Immediately I asked the watchman not to do so, in reply he started abusing me with filthy languages. The said watchman also stated that he is the staff of Dr. Arunangshu Shil and he had instructed him to beat any animal which comes near by the complex, in between this time some local people assembled around us, those people were saying that Dr. Arunangshu Shil is a man of cunning nature and he often indulges himself into various kind of foul behavior with the local people.

Hearing such hue and cry Dr. Arunangshu Shil along with few of his staffs came down and started abusing us with filthy languages, on my protest he and his men became violent and started assaulting me with fist and blows, Seeing this my wife who were there along with me on that day at that time, came in front to resist me from that physical assault, she was also subjected to some fists and blows on her person, by this time local people came and rescued us and we left the spot.

In view of the above facts you are, therefore, requested to investigate into the matter and take immediate necessary action against the culprits.
