I would like to bring to your kind notice & attention on an incident of serious nature involving a Vidyawati Agarwal of Siliguri college who is spreading hatred and making derogatory statements against Quran & Islam. The details of the incident are as follows:

2. Designation: Professor

Details of the Incident:

1. The accused Professor Vidyawati Agarwal has been actively spreading hate among students by making inflammatory statements and comments that are aimed at creating religious discord and animosity against a particular religious community. These actions have created a hostile environment among minority communities in town.

\* Vidyawati Agarwal has been posting statements against Islam on social media platforms which are reckless and misleading according to the teachings of the Quran. The statements shared by her not only misrepresent the religion but also offend the sentiments of Muslims both in and out of the wider community.

The statements by Vidyawati Agarwal are not only unethical, communal and unpatriotic but also violate the principles of secularism and harmony enshrined in our Constitution. Such behaviour is in direct contravention of deliberate and multifaceted measures intended to nurture religious beliefs of all citizens by insulating the religion or religious beliefs of our country from any threat.

Henceforth there may be every possibility of violence due to this offensive remarks shared on Social Media Platform thrown against a particular community.
