Subject – Written Complaint

Respected Sir,

I, GURIYA DAS, D/o- Madan Das, resident of Central colony, Gate bazar Quarter no 88/B siliguri, P.O- Bhaktinagar, P.S- NJP, Dist- Jalpaiguri, Pin- 734004, West Bengal would like to bring your attention towards on following facts which are as follows:-

1. That I am a law abiding and peace-loving citizen of this country and is also a lawyer by profession.
2. That I do hereby lodge this Written Complaint against the accused persons namely 1) Bablu Das, S/o- Madan Das and 2) Mini Das, W/o- Bablu Das, both are resident of Central colony Gate bazar Quarter no 88/B siliguri, P.O- Bhaktinagar, P.S- NJP, Dist- Jalpaiguri, Pin- 734004, West Bengal.
3. That on 05.07.2024 at around 11:45pm I was in my home and was doing some household chores. At that very moment I heard some noises from outside, so when I ran to see what had happened, I saw that my brother namely Bablu Das and my sister-in-law namely Mini Das both of them were abusing in very filthy and foul language and started beating my father namely Madan Das and my mother namely Gita Das with fist and blows.
4. That when I went to save them, said Bablu Das started beating me and dragged me by my hair, and threw me in corner and tore my clothes in a very shameful manner which I was wearing at that point of time and thereby molesting me. When my younger brother came to save me and tried to stop them from beating me, my sister-in-law namely Mini Das assaulted and slapped many times on the face of my younger brother namely Aditya Das and said Bablu Das also started beating him with hands and feet and even with a stick in brutal manner.
5. That I would also like to mention that said Bablu Das is a habitual drinker and he comes home drunk everyday and after drinking he abuses me and my parents in very

bad and filthy language and sometimes in many instances said Bablu Das along with his wife Mini Das even tried to kill my father Madan Das.

6. That also I have come to know that he is also addicted to drugs and deals in drugs which we were not aware of earlier but his wife i.e. my sister-in-law already knew about it and also supports him.
7. That after molesting and brutally beating me and my parents they have threatened us that they will make sure that me and my family members would be thrown out from our house and have also threatened me and my parents with dire consequences.
8. That after this incident I went to near N.F. Railway Hospital, NJP for treatment and I was prescribed some medicines and suggested to some tests and proper rest and care.

That considering all the facts I am writing this written complaint before your good office to kindly look into this matter and take proper steps as per provisions of the law, for this I will be very grateful to you.
