With due respect I, PARTHA SARATHI BASU s/o Late Swaraj Kumar Basu residing at 18 Benu Bhawan, opposite Patgola, APC Sarani, Deshbandhu para, Siliguri, West Bengal – 734004. On 3rd July, 2024 returning from Suraksha Diagnostic at near about 01:15 PM, I was just entering in my house & opening the main gate & then opened my garage. At that time two person like salesman came inside of my premises and started describing about some powder which can clean tiles, marble etc.

In few seconds they showed one of their silver ring shining as demo and immediately they gave some powder of copper colour in my hand and put some water in my hand which was feeling very cold. Immediately one of the person just look at my rope gold chain along with Loknath Baba's gold locket of total weight of 20 Grams, I was speechless standing near them, they put the chain in a plastic packet full of some white powder & stapled the packet with a stapler to open after 10-15 minutes.


Immediately they both went out of my gate, suddenly I felt like to open the packet & checked the gold chain was inside the packet or not & I made to drop the powder when I came into sense. But no chain was there.

I immediately took my bike out of my garage & try to follow them towards APC Sarani, Deshbandhu Para, Bela Bakery more, Dadabhai more, YMA Ground, Lake town area. But I could not find anyone of them anywhere.


After that I immediately went to Siliguri Police station to inform you all about the happenings.
