With due respect, I Raina @ Heena, daughter of Md Roshan resident of Vivekananda nagar, Word no. 7 of S.M.C. Po & Ps- Siliguri District Darjeeling, beg to inform you that my mother namely Rezwuna Begum wife of Md Roshan, has lodged a written complaint against 1) Md Aftab, 2) Sabana Khatun, 3) Md Munawar, 4) Ruksana Begum, 5) Md Samruddin, 6) Md Nawshad, 7) Tahina Khatun, 8) Khushbu Khatun, on such complaint Siliguri ps case no. 493/2024 Dated 23/05/2024, under section 417/376/41/323/325/506/34 of IPC was started, subsequently section 6 of POCSO Act has been added in the abovenoted case, subsequently all the above named accussed persons were released on anticipatory bail, except the principal accussed person Md Aftab.

Since the time the above noted accused persons have been released on bail, they have been threatening us to withdraw the case, but we did not agree.

Today, at around 2.30 pm I along with my mother Rezwana Begum were going to thokar via Jhankar more, at that time said in the leadership of 1) Md Munawar, s/o Md Moktar Qureshi, 2) Sabana @ Sabnam Khatun, w/o Md Munawar, 3) Md Samsher, 4) Md Parvez, both sons of Abdul Ahamed @ Bechu, 5) Rukshana Begum all resident of the abovenoted address caught us near "Nabadoy Rukshana Begum all resident of the abovenoted address caught us near "Nabadoy Sangha" and again threatened us to withdraw the case, when we protested, all of Sangha" and assaulting us with fist and blows, they torned our clothes, pulled us them started assaulting us with fist and blows, they torned our clothes, and started by grabbing our hair, then they brought out iron rods and hokey stick, and started assaulting my mother with those on her head and all over her body, when I tried to rescue my mother, they have assaulted me on my face hand, and also
