I, PINKI BISWAS, wife of Sri. Sushanta Biswas, permanent
s/o. Vill. Kawakhali, Bidhan Pally, near Harichand Mandir,
P.O. Sushrutanager, P.S. Matigara, Dist. Darjeeling, would
like to inform you that as follows:-

1. That Sri. Sushanta Biswas, son of Sri. Subodh Biswas is
my legally married husband. Since my marriage I have
been residing with my husband and my In-laws at my
above mentioned address. As because my husband
is doing a private job he has to reside in Delhi.
2. That ever since my marriage, in the absence of my
husband, my father-in-law namely 1. SUBODH BISWAS,
son of Late Rajendra Nath Biswas 2. my mother-in-
law namely TAPAYNA BISWAS, wife of Sri. Subodh
Biswas and 3. my brother-in-law namely TAPASH
BISWAS, son of Sri. Subodh Biswas all use to torture
me both physically and mentally. They always use
slang and abusive languages towards me. They
often demands a sum of Rs. 5,00,000/- least, golden
ornaments and furnitures from my father and when
he fails to fulfill their demands they assault
me brutally on my persons and asks me to get out
from their house.
3. That I am blessed with two children, one boy child
namely Shuvo Biswas (aged about 9 years) and one
girl namely Dishu Biswas (aged about 6 years). My
In-laws even tortures my minor children by depriving
them ^{from} basic requirements. In fact my In-laws
use abusive and filthy languages towards my
children unnecessarily. My husband incessantly
requested my In-laws not to torture me and my
children but in-vain. I tried to change their nature
and character with my love and care all these
years but no fruitful result.

That on 08.07.2024. at about 11:30 A.M. when I was sleeping along with my children suddenly my father-in-law, brother-in-law and mother-in-law entered my room and asked me to get out of their house after taking all my belongings and told me to return back only after bringing Rs. 5,00,000 from my father. When I denied to leave my house they became furious and started to assault me on my persons by fists, kicks and blows and with anything they found nearby. All the above persons tore my clothes. I anyhow locked myself and my children in my house. They threatened me that if I can do not bring money then they shall kill me by setting fire on my persons after pouring kerosene oil.

I therefore request you to kindly take necessary legal steps against the aforesaid 1. SUBODH BISWAS 2. TAPASH BISWAS and 3. AYNA BISWAS. I shall be highly obliged to you forever.
