Respected Sir,

With due respect I, Smt. Nilima Saha, Wife of Late Nimai Chandra Saha, resident of 52, C.R. Das Sarani, Purba Vivekanada Pally, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist.- Jalpaiguri, would like to draw your kind attention to the following facts:-

1. That I purchased the land measuring about 10.5 katha under R.S. Plot no. 9/486 and 10/495, recorded in R.S. Khatian no. 600/9, R.S. Sheet no. 11, Mouza - Dabgram, P.S. Bhaktinagar, Dist. Jalpaiguri, by the strength of a registered deed of sale bearing no. 1002 of 1989, registered in the office of the A.D.S.R., Jalpaiguri. Since the date of purchase I started possessing, occupying and enjoying such land.
2. That I transferred the land measuring about 6 katha out of 10.5 katha to one Arabinda Ghosh and Sujata Ghosh by way of sale. After selling such land I am the owner of the remaining land measuring about 4.25 katha. Even the land measuring about 10.5 katha was mutated in my name vide Mutation Case no. IX-2/504 of 1983-84.
3. That in due course of time L.R survey was conducted and the R.S. Plots were converted into L.R. Plots. My land measuring about 4.25 katha or 0.07 acre has been recorded in my name under L.R. Plot no. 160, recorded in L.R. Khatian no. 194, Mouza – Dabgram, L.R. Sheet no. 73, J.L. no. 2, P.S. Bhaktinagar, Dist. Jalpaiguri.
4. That I am an old aged lady and my age is about 84 years. I am suffering from old aged ailments. Presently my sons are looking after the land. The land has been surrounded by pucca boundary in two

parts. We have been continuously possessing the land since the date of my purchase.


5. That one Prasanta Roy, Son of Late Jagadish Roy, resident of Amtala Chayan Para, P.O. Eaktiasal, P.S. Bhaktinagar, Dist. Jalpaiguri and his associate Dhananjay Ray, Son of Chilesbari Ray, resident of Chayan Para, Bhaktinagar, Jalpaiguri are the land grabbers and brokers. Since long they are trying to capture my land. Recently I came to know that they have manufactured a false document and attempted to sell my land. Their prime intention is to gain huge amount by misleading third parties. They have no documents but they are trying to sell it by making forged documents.

6. That moreover they together are disturbing my possession. I intend to construct a residential house on my land and accordingly I engaged my sons to do the needful. When my sons engaged labours on 05.07.2024 to clean the land, the above mentioned two persons Prasanta Roy and Dhananjay Ray threatened my sons with dire consequences. They have threatened my sons to kill. Furthermore they affirmed there that they would certainly capture my land in future.

Therefore I request you to investigate into the matter and to take legal action against them and thereby I shall be obliged to you.
