With due honour I Jay Ram Tiwari S/o Lt. Kedar Tiwari resident of Ram Narayan Math, Gurung Basty, SMC Ward No.3, P.O. & P.S. Pradhannagar, Siliguri, District Darjeeling, West Bengal, PIN 734003 is lodging this complaint to the effect that I along with my brother Sri Hare Ram Tiwari were sitting at our shop namely Tiwari Hardware Stores at Nivedita Road, Gurung Basty, Pahelwan Compound, SMC Ward No.3, P.O. & P.S. Pradhannagar, Siliguri, District Darjeeling, West Bengal, PIN 734003 and at a sudden Sri Biseshwar Tiwari Son of Lt. Kedar Tiwari, along with his two sons Sri Sonu Tiwari and Rahul Tiwari came to our shop on 08.07.2024 at around 7.00 to 7.30 p.m. and before we could judge their motive, Sonu pushed me and I fell down and my brother fell over me and they started physically assaulting of us, In the meantime Biseshwar Tiwari picked up the chair and hit it towards my brother, Sonu Tiwari and Rahul Tiwari pick up hammer (Hatoda) and other iron article from our shop and attacked upon us at once and gave us no chance to escape, They hit the hammer and other iron article over the head of my brother. They also started using fists and blow by the time we could defend ourselves the damage was done and my brother is seriously injured at his head and blood was bleeding and I was also hit by the fist and blows at my lips and hit my teeth, That said three persons with an intention to kill me and my brother have tried to hit us with hammer and other iron article but were unable to succeed in their

plan as on hearing our shout for saving us the neighbors and the passerby came to our rescue and saved us on seeing the crowd gathering they ran away, But while running they threatened to come again and kill us and shall not leave us. The neighbor and other persons took us to the Medica North Bengal Clinic where my brother was treated and I was taken to the Siliguri District Hospital at emergency.

Under such constrained circumstances I hereby lodge this complaint against Biseshwar Tiwari Son of Lt. Kedar Tiwari, and his two sons Sri Sonu Tiwari and Rahul Tiwari resident of Durganagar Colony, SMC Ward No. 3, P.O. & P.S. Pradhan Nagar, Siliguri Dist. Darjeeling Pin 734003 (W.B.), and would request you to do the needful as soon as possible so that the wrongdoer's can be punished as per the procedure established by law and provide adequate protection to us.
