After the said marriage my father gave gold ornaments of about 1000 rupees and I brought the gold ornaments in my ^{said} matrimonial house.

The said abovementioned persons took all the gold ornaments on 06/07/2024 at about 1:30 pm and started beating by daughter namely Sunita Biswas aged 17 years on her limbs which amounted to severe pain on her limbs and thereafter I took my daughter to Siliguri District Hospital for her treatment.

Even after several requests to them, they did not listen to any of ~~my~~ my request and continued to block the water drain and closed the main gate. Thereafter they also captured my husband's shop situated at the same address and did not let us open the shop.

And also they used to torture me and my husband continuously and used to hit my husband which resulted injury in his eyes for which the treatment is still going on at Lion's club for which the cost of per injection was Rs. 50,000. But the said persons did not give any amount for my husband's treatment. Therefore I am lodging my complaint.
