I am writing to bring to your urgent attention a matter of grave concern that has been affecting the security of the ATM Counter located on my premises in Tumba Jote, Matigara near West Point School. This ATM counter vide Id No: - S1NB004789135 has been in operation by the State Bank of India since 2015, under an agreement we have maintained with (copy attached).

On the following dates:- 13<sup>th</sup> June 2024, 25<sup>th</sup> Jun 2024, & 6<sup>th</sup> July 2024, an unauthorized gained entry into the ATM counter with clear intentions of theft. These incidents have been captured in the CCTV Footage, which I am submitting here with for your immediate review and necessary action please.

The repeated occurrence of such criminal activities is not only alarming but also possess a significance threats to the safety and security of our community. It is imperative that these incidence be addressed with utmost serlousness to prevent any future occurrences.

I kindly request your esteemed office to intervene in these matter promptly and take the necessary actions immediately to ensure that such illegal activity are curved. Your co-operation in these regards will be highly appreciated and will go a long way in safeguarding our premises and ensuring peace of mind.
