SUBJECT: WRITTEN COMPLAINT

Respected Sir.

I, **SRI AJIT MAHATO**, resident of Ganga Nagar, Near Muni Baba Mandir, Ward No. 5, presently residing at Nivedita Road by lane, Pradhan Nagar, Siliguri hereby inform you that

1. That this is to inform you that I and my wife do not have the financial status to afford a four-wheeler.
2. That my friend namely **MD. KALAM KHAN** S/O Md. Khalil Khan of Holding No. 4/508, Chayan Para, Opposite Dosti Enclave, Salugara, P.S. Bhaktinagar, permanent resident of 148 Ahmad Nagar, Chhiri, Valsed Gujarat 396191 requested us and also deposited a cash of **Rs. 4,95,000/-** as down-payment and also took responsibility to deposit the sum of **Rs. 20,900/-** as EMI of the said vehicle in my account against a vehicle TATA NEXON, Colour - White, having Registration No. WB 74 BQ 1444 (as fully described in the Schedule below) purchased with the financial assistance of MAHENDRA AND MAHENDRA FINANCIAL SERVICE LTD. in joint name of me and my wife RINA MAHATO in the month of August, 2023.
3. That a Deed of Agreement for Settlement and Liability of Vehicle in Possession was executed between my friend MD. KALAM KHAN and me and the said vehicle was in my friend MD. KALAM KHAN's possession since **16/11/2023** and he requested to us to take the vehicle for his personal use for few days, and said MD. KALAM KHAN took the vehicle to his permanent residential area at Gujarat, but he didn't pay any instalment in my account against the vehicle's EMI till date.
4. That whenever the said MD. KALAM KHAN didn't pay any EMI for the vehicle I reached at the house of the said MD. KALAM KHAN and returned back to Siliguri with the said vehicle and with the said MD. KALAM KHAN, in the month of **May 5th, 2024**.
5. That again on 10th June, 2024 the said MD. KALAM KHAN took the said vehicle at Alipurduar as informed by the local public and Financer of Alipurduar.
6. That I enquired about the vehicle to the said MD. KALAM KHAN, but he also informed me that the vehicle was stolen from his possession.
7. That now me and my wife have fall in a serious pressure and depression as the financial company is continuously pressuring us to clear the loan amount of my stolen vehicle.
8. That I entrusted the below schedule vehicle in favour of the said MD. KALAM KHAN but he dishonestly misappropriates the said property for his wrongful gain.

Thereby I humbly request you to recover the said vehicle and to take necessary legal action against the concerned offender MD. KALAM KHAN of Holding No. 4/508, Chayan Para, Opposite Dosti Enclave, Salugara, P.S. Bhaktinagar, permanent resident of 148 Ahmad Nagar, Chhiri, Valsed Gujarat 396191, and do as per your convenience.
